No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
4. VFDs Chiefs' Reports; review and discuss Monthly Run Reports and other records submitted by the VFDs.
5. District Manager's Report.
6. Review and approve minutes of the January 18, 2016 regular meeting.
7. Treasurer's Report.
8. Review, discuss and take action to approve and authorize payment of the District's bills and accounts; and, review, discuss and take action to approve VFDs' emergency expenditures being submitted for reimbursement and authorize payment of same.
9. Discuss and take any needed action regarding VFD members' use of District equipment as members and while providing services for other departments outside of the District.
10. Review, discuss and take action on proposed purchases of equipment and/or supplies, proposed equipment repairs, maintenance and/or testing, as well as any purchase, repair, and/or maintenance requests submitted by the VFDs.
11. Discuss and take any needed action regarding a cost analysis and/or feasibility study on paid medics to provide EMS service within the District, along with proposals from third-party private entities to provide said services for the District.

12. Discuss and take any needed action regarding retention of special counsel to review and consult on the District's policies, procedures, service agreements, and operations.
