OF JEFFERSON COUNTY EMERGENCY SERVICES DISTRICT NO. 4**



No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
4. VFDs Chiefs’ Reports; review and discuss Monthly Run Reports and other records submitted by the VFDs.
5. District Manager’s Report; review, discuss and take action on renewal of District Manager’s service agreement.
6. Review and approve minutes of the following Board meetings.

 - April 4, 2016 special meeting.
7. Treasurer’s Report.
8. Review, discuss and take action to approve and authorize payment of the District’s bills and accounts.
9. Review, discuss and take action on proposed purchases of equipment and/or supplies, as well as any proposed equipment repairs, maintenance and/or testing.
