7. Treasurer's Report.
8. Discuss and take action on obtaining a credit card for the District Manager.
9. Review and discuss status of the VFDs' proposed 2015-16 annual budgets, and preparation of the District's 2015-16 annual budget.
10. Review, discuss and take action to approve and authorize payment of the District's bills and accounts; and, review, discuss and take action to approve VFDs' current operation and maintenance expenditures being submitted for payment/reimbursement by the District, and authorize payment of same.

12. Review, discuss and take action on equipment repair, replacement and/or acquisition proposals, as well as any other expenditure requests submitted by the VFDs, along with the repair/improvement proposals for the Cheek VFD fire station, and purchase of a copier for Labelle-Fannett VFD.
13. Discuss status of the 2014 Pierce mini-pumper purchase and financing for same, and take any needed action.
14. Status update on District's fiscal year 2014-15 audit; review and discuss information and materials requested by the District's auditor.
