In accordance with the Texas Attorney General’s opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
4. District Chief’s Report.
5. Review and approve minutes of the September 15, 2025 public hearing and regular meeting.
6. Treasurer’s Report, and review and take action on any proposed budget amendments and necessary account fund transfers (transfer funds to District’s TexSTAR investment pool account).
7. Review, discuss and take action on proposed purchases/expenditures, including proposed AED purchase and the District’s Property/Liability Insurance renewal.
8. Review, discuss and take action to approve and authorize payment of the District’s bills and accounts, including, but not limited to, the District’s property and liability insurance renewal premium.
9. Review, discuss and take action to accept Texas A&M Forest Service apparatus grant.
10. Discuss and take any needed action regarding new Fannett fire station design/build, including, but not limited to, review of qualification submittals and ranking/choosing of owner’s representative, and authorize publication of request for qualifications for retention of a design/build firm for new fire station construction.
