Review, discuss and take any needed action regarding new Fannett fire station design/build, including, but not limited to, approval/ratification of owner’s representative service agreement with Fittz & Shipman, and approval/authorization for posting/publication of request for qualifications for design/build firm.
10. Review, discuss and take action to declare salvage/surplus property and authorize disposal of same.
11. Such other matters that may come before the Board.
